### 1.0. MISSION

1.1. The Ohio Special Response Team (OSRT), Incorporated is a broad based response unit able to respond to a variety of emergencies and disasters in support of the civil authorities. Possessing a range of skills increases the value and versatility of the unit to the civil authorities. Members of the unit are trained to rigid standards in a number of skills to assure they can accomplish the assigned task(s).

### 1.2. PURPOSE

1.2.1. The OSRT is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law. The specific purposes of the OSRT are:

1.2.2. To support local, state, and federal authorities in the event of a natural and/or man-made disasters or emergencies.

1.2.3. To provide assistance to the authorities relating to non-disaster situations and/or incidents.

1.2.4. To conduct training programs in subjects related to emergency response incidents and/or situations.

1.2.5. To offer educational courses to the general public relating to the mission of the organization.
